
Installation & Use Instructions: For 2018 - Current Jeep® Wrangler (JL)

⚠ WARNING ⚠

READ AND FOLLOW ALL INSTRUCTIONS. Unsecured Front Liners may shift, restricting pedal movement which may lead to loss of vehicle control. TO AVOID RISK OF SERIOUS INJURY: Front Driver's Side Liner MUST Be Secured with the anchors that came with your Jeep®. Replace factory carpet anchor if damaged or missing. DO NOT STACK ANY OTHER LINERS OR MATS OVER OR UNDER your Ultimate Floor Liner. Floor Liner MUST be anchored directly to carpet.



Step 1: Permanently remove all existing factory or aftermarket floor mats or liners. Do not stack or combine your new floor liners over any other floor mats or liners. For best results, we recommend vacuuming your vehicle carpet before installation. Make sure carpet is dry.



Step 2: Place the driver side liner down into position and align the original equipment carpet anchor buttons with the anchor discs in the Quadratec floor liner. Press down on the anchor discs in the floor liner and make sure that they click and lock into place as shown in Figure 2.



Step 3: Repeat steps 1 and 2 on the passenger side and rear floor liner (if applicable).

The Rear 4 door liner is shown in Figure 3 with carpet anchors engaged.

Use and Enjoy! Enter and exit your vehicle in foul weather without worry. When floor liners are dirty, simply remove as needed and hose them off.

All other warranties are hereby disclaimed, except to the extent prohibited by applicable law in which case any implied warranty of merchantability or fitness for a particular purpose on this product is limited to 1 year from date of initial retail sale. Quadratec reserves the rights to: (a.) require invoice or other proof your Ultimate Liner is within the terms of this **Limited Warranty** as a condition of warranty service and, (b.) make future revisions to this product and **Limited Warranty** without prior notice or obligation to upgrade your product.

What is not covered:
